ACKNOWLEDGEMENT

I acknowledge that:

- I am the participant/I am a parent or guardian of The Minor
- I /The Minor is being supplied with a recreational service by the Club.
- The Activity is a dangerous recreational activity that involves a significant risk of physical harm.
- I/The Minor and Parent/Guardian may be injured in performing the Activity.
- The natural conditions in which the Activity is conducted may vary without warning.
- My/The Minor and Parent/Guardian participation in the Activity is voluntary and I/we have not been required by the Club to engage in the Activity.
- I/The Minor and Parent/Guardian have disclosed any pre-existing medical or other condition that may affect the risk that either I/The Minor and Parent/Guardian or any other person will suffer injury, loss or damage.
- The Club relies on the information provided by me/The Minor and Parent/Guardian and I/The Minor and Parent/Guardian state that all such information is accurate and complete.
- I am aware of the dangers associated with the consumption of alcohol, mind-altering substances, drugs or other substances that may impair my /The Minor and Parent/Guardian's judgment or physical ability or capacity to safely participate in the Activity and accept full responsibility for any injury, loss or damage associated with my consumption of alcohol, mind-altering substance, drugs or other substances which impairs my/The Minor and Parent/Guardian's judgment, physical ability or capacity to safely participate in the Activity.
- I/The Minor and Parent/Guardian have not relied upon any advice, representations, or inducements by or on behalf of the Club in deciding to:
 - o (i) participate/allow the Minor to participate in the Activity; and
 - o (ii) sign this document.

RISK WARNING

1. I/The Minor and Parent/Guardian acknowledge that I/we have been warned of the Risks of the Activity.
2. I/The Minor and Parent/Guardian acknowledge that the Activity may also involve other risks not noted in the Risks of the Activity listed on page 1.
- 3A. The Club has placed signs around the site on which the Activity is to be performed warning of the risk of injury. I/The Minor and the Parent/Guardian have read the signs and understand the warnings provided.
- 3B. The Club has provided me with oral warnings of the Risks of the Activity and the risks of physical harm in participating in the Activity.

ASSUMPTION OF RISK-PHYSICAL INJURY and DEATH

1. Notwithstanding the significant risks of physical harm and injury inherent in the Activity, some of which are noted above, I/The Minor and Parent/Guardian agree to participate in the Activity at my own risk.

WAIVER, RELEASE, AND INDEMNITY

1. I/The Minor and Parent/Guardian agree that the provisions of Competition and Consumer Act 2010(Cth) and any similar state legislative provisions (which provide for an implied warranty that services be rendered with due care and skill and that any material supplied in connection with those services will be reasonably fit for purpose) are excluded other than the extent to which those provisions allow the providers of recreational services to contract out of the implied warranties in so far as they relate to liability for physical injury or death from the Activity.
2. I/The Minor and Parent/Guardian agree to release and hold harmless the Club its servants, employees and agents from and against any liability arising out of any physical injury or death of me/The Minor and Parent/Guardian or any other person claiming through or on their behalf arising from or in connection with my or their participation in the Activity whether such physical injury or death was caused directly or indirectly by negligence, breach of contract or any way whatsoever other than where the physical injury or death was caused solely by the negligence of the Club, its servants, employees or agents.
3. I/The Minor and Parent/Guardian agree to indemnify and hold harmless the Club, its servants, employees and agents from all claims, damages and expenses arising out of or resulting from my/The Minor's and Parent/Guardian's participation in the Activity. This indemnification extends to all claims made by The Minor and Parent/Guardian and any other person against the Club, its servants, employees, volunteers or agents in respect of any physical injury or death arising out of or in connection with my/The Minor's and Parent/Guardian's participation in the Activity, other than where the physical injury or death was caused solely by the negligence of the Club, its servants, employees or agents.

MISCELLANEOUS

1. I/The Minor and Parent/Guardian agree to report all accidents or injuries sustained by me to the Club before I leave the site on which the Activity is performed.
2. I/The Minor and Parent/Guardian agree to comply with all rules and directions made or given by the Club in connection with the Activity. I/The Minor and Parent/Guardian understand that if I/we fail to comply with the rules and/or directions of the Club, I/The Minor and Parent/Guardian may be injured or injure someone else. Further, I/The Minor and Parent/Guardian understand that I/we will not be permitted to continue the Activity and no refund will be given.
3. I/The Minor and Parent/Guardian agree that if I/we suffer any injury or illness I/we agree that the Club may provide or arrange evacuation, first aid and medical treatment at my expense.

ASSUMPTION OF RISK-PROPERTY LOSS and/or DAMAGE

Notwithstanding the significant risks of property loss and/or damage inherent in the Activity, some of which are noted below, I/The Minor and Parent/Guardian agree to participate in the Activity, notwithstanding the below risks.

Risks:

- (a) My/The Minor's and Parent/Guardian's personal property may be lost, damaged or destroyed in performing the Activity.
- (b) Other people may cause me/The Minor and Parent/Guardian injury or may damage my/The Minor's and Parent/Guardian property in the course of performing the Activity.

(c) I/The Minor and Parent/Guardian may cause injury to other persons or damage their property in performing the Activity.

I/The Minor and Parent/Guardian ACKNOWLEDGE THAT HAVE READ THIS FORM AND THAT IT HAS BEEN EXPLAINED TO ME/US. I/The Minor and Parent/Guardian FULLY UNDERSTAND ITS TERMS AND THAT I/WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT. I/The Minor and Parent/Guardian SIGNED THE DOCUMENT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT MADE TO ME/US.

I/The Minor and Parent/Guardian agree that the above assumptions of risk, waiver of your rights, release, and all other obligations on me as set out above may only be withdrawn by notice to the Club signed by the participant and or Parent/Guardian. The notice becomes effective on the next Club day after the Club receives it (or any later date specified in the notice)/.
